## A Campaign for Sun Shelters and Shade Trees in the Village's Premier Park

**Site Description**—Joshua's Park on Courthouse Road, Amherst Village

**Proposed project amenities**—

- (1) Two shade structures matching the original playground equipment, placed by the playground area.
- (2) One wooden pergola erected to shade the granite benches at the garden patio.
- (3) Five to seven sizable shade trees to provide for future shade, as they grow, over 20 to 30 years.
- (4) Picnic tables and benches for the shade structures.

The two playground structures, one 14 x 22 feet and another 10 x 15 feet, will be outfitted with seasonal fabric roofs, removed during winter, leaving only two poles color-coordinated with the playground. The structures will shelter four picnic tables to be built by Amherst Recreation Department.

**Fundraising Goal**—\$20,000.00 (any extra money raised will go directly into improvements to the park)

**Targeted Completion Date**—June 30, 2021
